Dufry files Mandatory Tender Offer with CONSOB

NOTICE PURSUANT TO ART. 37-TER, PARAGRAPH 3, OF THE REGULATION ADOPTED BY CONSOB BY RESOLUTION NO. 11971 OF MAY 14, 1999, AS SUBSEQUENTLY INTEGRATED AND AMENDED (THE “ISSUERS’ REGULATION”).

Mandatory public tender offer launched by Dufry Financial Services BV (“Dufry” or the “Offeror”) on all the ordinary shares of World Duty Free S.p.A. (“WDF”) other than those already held by the Offeror.

With reference to the mandatory tender offer (the “**Offer**”) announced by Dufry pursuant to articles 102 and following of the Legislative Decree no. 58 of February 24, 1998, as subsequently integrated and amended (the “**TUF**”), having as object all the ordinary shares of WDF other than those already held by the Offeror, we hereby communicate that on August 24, 2015, pursuant to article 102, paragraph 3, of the TUF and to article 37-ter of the Issuers’ Regulation, Dufry filed with Consob the tender offer document (the “**Offer Document**”).
